Paintbrush, with a cloth or sponge, single brush machine.

The product can be applied by paintbrush, spraying, with a cloth or preferably with a sponge making sure to apply the amount that the material naturally absorbs evenly. A few seconds after application, remove from the surface the QUARTZ TONER in excess with a clean cloth or by using a single brush machine to prevent the formation of surface sticky films. For best results repeat the treatment after about 10-15 minutes from the first application. In case of floors, wait at least 24 hours before walking on the floor.
