

Lithofin MN Refresh for (Quartz)Composite

Description

Lithofin MN Refresh is a special product from the LITHOFIN-Range for quartz composite and similar artificial stones. The special impregnator contains water and oil repellent additives and has been specifically designed to touch up the effect of pre-applied protective treatments. All active ingredients are uv-resistant and do not yellow.

Properties

Lithofin MN Refresh is easy to use on all quartz composite surfaces, and it does not alter the original appearance of the surface.

The active ingredients render the surface water and oil repellent, effectively slowing the adhesion of water borne dirt, oil and grease. This effect helps to prevent staining and greatly simplifies maintenance cleaning.

Field of Use

For regularly touching up (refreshing) quartz composite surfaces that have been pre-treated with a protective treatment. Maintains the even appearance of kitchen counter tops, tables, vanity tops and similar small surfaces.

Please Note: the protective effect does not alter the surface's sensitivity to acidic substances. The surface may become slightly darker with frequent use.

Recommendation: always wipe up any spills immediately, even when the surface has been treated with a protective treatment. For regular cleaning use Lithofin MN Easy-Clean.

Directions for use

The surface to be treated must be dry and clean. Prepare the surface by thoroughly cleaning it with Lithofin MN Power-Clean.

The surface temperature should be between 10 and 25°C. Always work in small, manageable sections.

1. Apply a small amount of product to the dry surface and immediately distribute evenly with a clean cloth.
2. Keep towelling the surface until it is dry and free of smears.
3. Repeat procedure on next section.

Please Note: glass, plastics, polished and lacquered surfaces and any other sensitive surfaces must be protected against splashes.

Coverage: up to 40 m²/Ltr.

Drying Time: approx. 3 min.

Storage

Closed, cool, frost-free. Shelf life of approx. 3 years.

Environmental Protection

Does not contain any organic solvents.

The contained surfactants are biodegradable according to regulation (EC) No. 648/2004 (detergents regulation).

Disposal: waste code according to EWC/AVV 07 01 04*.

Bottles/canisters are made of environmentally friendly polyethylene and can be recycled (see information on label).

Safety

Treated surfaces present no health hazard once dry.

Product is suitable for areas where food is handled.
